**Approval for Additives to Construction Contract – Job No. F54B609A,  
Wailua River State Park, Marina Roadway and Parking Lot Resurface  
Wailua, Kauai, Hawaii**

The Land Board approved the construction contract on February 23, 2006 for the sum of \$ 394,941.30 to **JAS. W. GLOVER, LTD.** for the basic and additive bid item #3. Additional funding for additives #1, #2, #4, #5 and allowances totaling **\$530,000.00** for this project are available from Transient Accommodation Tax (TAT) revenues received from the Hawaii Tourism Authority (HTA).

The project consists of resurfacing the roadway and parking lot with asphaltic concrete pavement; construct concrete sidewalk and concrete ramp with railing; install ADA parking signs with posts, install detectable warning on pathways and install pavement striping.

**RECOMMENDATION:**





Bids for the subject project were received and opened on February 1, 2007, the results and recommendations are as follows:

Total Sum Recommended	<b>\$ 394,941.30</b>


The project consists of resurfacing the roadway and parking lot with asphaltic concrete pavement; construct concrete sidewalk and concrete ramp with railing; install ADA parking signs with posts, install detectable warning on pathways and install pavement striping. Due to funding availability, the basic and additive bid item #3 is recommended for execution. Item #3 provides for resurfacing of the service road between the marina facilities and Wailua River.

Funds for this project are available from Transient Accommodation Tax (TAT) and Hawaii Tourism Authority (HTA) revenues.

**RECOMMENDATION:**




